

#### **NEIGHBOURHOOD CIL APPLICATION FORM 2019**

#### What's Neighbourhood Community Infrastructure Levy (CIL)?

Neighbourhood CIL is intended to help address the demands of a new development on the local area. This neighbourhood proportion is up to 25% of CIL receipts in areas with an adopted Neighbourhood Plan and up to 15% (capped at £100 per existing council tax dwelling) in areas without a Neighbourhood Plan. Therefore, if development occurs in an area, funds will be collected for the community to use to mitigate any impacts they have identified

At Solihull, a bidding system is open to communities to attempt to secure funding for projects that will benefit the local area. The fund total will be released annually, in April, and these funds will be open to bids until August 16<sup>th</sup>. Solihull MBC aim to fund the most appropriate projects (for an area), to ensure this, a screening application form will enable officers to best allocate funding. The funding will be become available once the ward allocation pot reaches £10,000.

Training Equipment for Emergency Life Support

Project Summary:
We are applying for one training defibrillator at a cost of £250 (discounted from £353), a resuscitation junior manikin at £1,116.56 (discounted from £1,236) and one resuscitation baby manikin at £624 (discounted from £650. These figures exclude VAT as the charity can purchase training equipment with zero rate.  In September alone, FastAid volunteers have held <u>free</u> community training events for Knowle
Church, Knowle & Dorridge Running Club and an open evening at Dorridge Village Hall, attended by around 30 people. These are two hour sessions involving life saving techniques such as recognising a heart attack, cardio pulmonary resuscitation and the use of a defibrillator.  In October, we will be training the staff at Arden Academy and on October 16, 300 children at Arden school along with other schools across the Borough

Recently we have trained at Knowle and Dorridge Lions who we also support at community events.



As demand increases our class sizes get bigger and more equipment is required for 'hands on' training. We also work closely with Dorridge and District Residents Association and hold with them on average 3 free training sessions per year. At present, FastAid does not have any junior or baby training manikins and we ask our public to imaging the differences between adult and child resuscitation. More critically, we ask the same of our Community First Responders, yet one of our CFRs was awarded a commendation for a successful resuscitation of a 10 week old.

These modern skill manikins take the guesswork out of training and present a real opportunity to perfect CPR including chest compressions and rescue breathing.

#### Mitigating the impact of Development

There is a growing concentration of elderly people and more care & nursing homes are being built. As well as our Community First Responders getting to emergencies quickly, bystander intervention can be key to the outcome. We need to give more people the knowledge, skills and confidence to become involved in life saving techniques.

This involves hands on practical experience through state of the art manikins and training defibrillators. As we get more defibrillators in public places, more training is required. We only have two modern training defibrillators and to give realistic hands on experience, at least two more are an urgent requirement.

More children in the wards (and at Arden School) present a potential increase in demand for training and for use.

The FastAid constitution is about preserving and promoting good health

- a) Provide the relief of injury, sickness and the preservation of good health to persons in Solihull and surrounding areas by providing trained and equipped volunteers to attend emergencies, as directed by West Midlands Ambulance Service.
- b) Provide training and education to further the object and engage with the local community in health promotion activities.

'<u>Our Vision'</u> The most significant population change has been the rapid increase in the number of older residents. The 75 and over population in Solihull is expected to grow by around 700 per year over the medium term. By 2027 there are expected to be over 28,200 people of this age living in the borough.

Solihull has an aging population, especially true in Dorridge. Although cardiac arrests are not confined to the elderly, as people age so the chances of a sudden cardiac event increases. We also cover heart attacks, choking, strokes and severe bleeding in our training. Choking episodes are especially prevalent in children and the elderly. Choking is one of the causes of cardiac arrests in children.

FastAid volunteers are already closely involved with HeartStart training, in association with the British Heart Foundation. FastAid has invested in 9 training manikins and two training AEDs. (£3,700) Because of the nature of the hands on practical training, we require more to give more people the skills to buy time for the victim and to save lives.

The project will be overseen by the Trustees of FastAid and the committee.

FastAid was founded in 2005 in Solihull which remains its main base. It has the strength of 40 members including 5 members within or alongside the wards involved in the application. It will be recruiting from mid 2020, potentially adding another 10 CFRs. We have not been able to recruit as a new qualification programme is being developed by WMAS.

There is already a proven track record.

In 2016 FastAid was awarded the Queens Award for Voluntary Service, the MBE for voluntary groups.
